## McGEE ROAD WATERMAIN EXTENSION AKWESASNE, NEW YORK

Proposals will be received by the Saint Regis Mohawk Tribe (SRMT) Grants & Contracts Office, *Ionkwakiohkwaróron* Administration Building, 71 Margaret Terrance Memorial Way, Akwesasne, NY 13655 until 3:30 p.m. (Local Time), **Wednesday, July 2, 2025**. No public opening of proposals will be conducted.

SRMT is requesting proposals from Qualified Contractors to provide all labor, materials, tools, plant, equipment, supervision and incidentals necessary to furnish and install Option #1, directional drill installation of approximately 4,200 LF of 8" HDPE DR11 watermain pipe via directional drill method or Option #2, direct bury method of approximately 4,200 LF of 8"C900 PVC watermain pipe; all options will include five (5) new water service connections, connection to the existing watermain, fracturing and removal of rock, as needed and all required final restoration, with alternates and more particularly identified in the Proposal Documents.

SRMT is utilizing "Procore" construction project management software for viewing and downloading copies of all Proposal Documents. All electronic correspondence is tracked and archived by Procore and proposers are provided with the most up-to-date information for the project. Interested proposers must contact the SRMT's Grants and Contracts Office to be added to the proposers list for this project and to obtain proposal documents, drawings and technical specifications.

The *successful* Contractor, as well as their Sub-Contractors, will be required to complete a Native American Preference Employment Plan and Agreement.
