WALKING TRAIL EXPANSION AKWESASNE, NEW YORK

Proposals will be received by the Saint Regis Mohawk Tribe (SRMT) Grants & Contracts Office, *Ionkwakiohkwaróron* Administration Building, 71 Margaret Terrance Memorial Way, Akwesasne, NY 13655 until 3:30 p.m. (Local Time), **THURSDAY, SEPTEMBER 11, 2025**. No public opening of proposals will be conducted.

Qualified Contractors will provide all labor, supervision, materials, supplies, tools, equipment, transportation and incidentals necessary to construct approximately 2300 linear foot of walking trail to expand the current walking trail around the New Housing Development site at 760 State Route 37, Akwesasne, NY, to include, but not be limited to cutting and clearing low branches, limbs, saplings, brush and trees of 6" caliper or less to facilitate construction of a 6-ft wide trail through a wooded area, all more particularly described in the Proposal Documents.

In accordance with the Saint Regis Mohawk Tribe's Native American Preference Policy, the Saint Regis Mohawk Tribe will give preference in the award of a Contract to approved Native American Owned Business/Company, as certified by the Saint Regis Mohawk Tribe's Compliance Department. **ANY PROPONENT CLAIMING NATIVE AMERICAN PREFERENCE MUST GIVE EVIDENCE TO SUPPORT THIS CLAIM WITH THEIR SUBMITTED PROPOSAL.** The *successful* Proponent, as well as their Sub-Contractors, will be required to complete a Native American Preference Employment Plan and Agreement, upon request.
