Proposals will be received by the Saint Regis Mohawk Tribe (SRMT) Grants & Contracts Office, *Ionkwakiohkwaróron* Administration Building, 71 Margaret Terrance Memorial Way, Akwesasne, NY 13655 until 3:30 p.m. (Local Time), **THURSDAY, NOVEMBER 20, 2025**. No public opening of proposals will be conducted.

SRMT is requesting proposals from Qualified Contractors to provide all labor, materials, tools, plant, equipment, supervision and incidentals necessary for the construction of approximately 4,600 linear feet of 8" HDPE watermain and appurtenances including pressure testing, disinfection and incidental site restoration at the Saint Regis Mohawk Tribe's Transfer Station located at 179 County Route 43, Fort Covington, NY, all more particularly identified in the Proposal Documents.

SRMT is utilizing "Procore" construction project management software for viewing and downloading copies of all Proposal Documents. All electronic correspondence is tracked and archived by Procore and proposers are provided with the most up-to-date information for the project. Interested proposers must contact the SRMT's Grants and Contracts Office to be added to the proposers list for this project and to obtain proposal documents, drawings and technical specifications.

In accordance with the Saint Regis Mohawk Tribe's Native American Preference Policy, the Saint Regis Mohawk Tribe will give preference in the award of a Contract to approved Native American Owned Businesses/Companies, as certified by the Saint Regis Mohawk Tribe's Compliance Department. **Any proponent claiming Native American Preference must give evidence to support this claim with their submitted proposal.** The *successful* Contractor, as well as their Sub-Contractors, will be required to complete a Native American Preference Employment Plan and Agreement.
