TRIBAL COUNCIL RESOLUTION 2025 - 25

TO UPDATE SIGNING AUTHORITY FOR TRIBALLY-BINDING DOCUMENTS, SUCH AS GRANTS AND RELATED DOCUMENTS, CONTRACTS/AGREEMENTS, AMENDMENTS/MODIFICATIONS, LAND TRANSACTIONS AND RELATED DOCUMENTS, FINANCIAL DOCUMENTS, ETC.

WHEREAS, the Saint Regis Mohawk Tribal Council (the 'Tribal Council') is the duly recognized governing body of the Saint Regis Mohawk Tribe (the 'Tribe') and is responsible for the health, safety, education and welfare of all community members; and

WHEREAS, the Tribal Council possesses the authority to enact ordinances and adopt resolutions, not consistent with Federal law or the Tribe's status as a federally recognized Indian Tribe; and

WHEREAS, the current terms of office for elected Tribal officials are as follows:

July 1, 2023 – June 30, 2026 Tribal Chief Michael Conners Sub-Chief Agnes Jacobs July 1, 2024 – June 30, 2027
Tribal Chief Donald Thompson, Jr.
Sub-Chief Benjamin Herne
Tribal Clerk Summer Bero

July 1, 2025 – June 30, 2028

Sub-Chief Derrick King

WHEREAS, the Tribal Chiefs possess signing authority to execute all grant awards and funding agreements, modifications and contracts with Federal or New York State agencies.

NOW, THEREFORE, BE IT RESOLVED:

1. Any two (2) out of three (3) Saint Regis Mohawk Tribal Chiefs named above have signing authority on behalf of the Saint Regis Mohawk Tribe for tribally-binding documents such as a grant awards, contracts/agreements, modifications and amendments to be entered into with Federal or New York State agencies, land transactions and related documents, financial documents including but not limited to checks, and any other such documents; and

- 2. In accordance with the Saint Regis Mohawk Tribal Procedures Act (Tribal Council Resolution 2013-32), Section IV. D. 2. the Chief may give authority to his or her Sub-Chief to act in his or her absence, or temporary inability to act, in writing with delivery to the Tribal Clerk, indicating the duration and extent of authority designated; and
- This Resolution is effective July 1, 2025 to June 30, 2028, or until the composition of the Tribal 3. Council changes; and
- This Resolution hereby supersedes Tribal Council Resolution 2024-28. 4.
